Dear Friends of Shore:

I am so excited to report to you what a wonderful year I have had as the President of the Board of Directors. It has been a privilege to work for such a worthwhile organization with an amazingly dedicated staff.

Once again this year, our Annual Meeting was held at Hackney's on Lake in Glenview. I was so proud and yet humbled by the terrific turnout of our staff, most of which were honored with 10 or more years of service. In addition, several of our clients were awarded for their various special achievements. Watching our clients receive these honors is most rewarding as it reminds me of why we are all so dedicated to Shore and inspires me to work that much harder to advocate for this amazing population of people.

Fiscal Year (FY) 2013 brought many new and exciting changes at Shore. I have had the privilege of working with our somewhat newly appointed Executive Director, Debora Braun. Her knowledge of the organization and eagerness to broaden our horizons by entering into a new era for Shore has been encouraging. With a 62 year history, we look forward to a bigger and brighter future.

As President of the Board of Directors, it is my goal and purpose to leave behind after my tenure an organization that is stronger and better than when I first arrived. One of the most important goals I have is to broaden our income base relying less of the State of Illinois and more on private funding. Though cash flows received from the State stabilized in FY '13, the State continues to be behind in payments, which has a crippling effect on our ability to expand and improve our programs and facilities. We also began looking into ways to increase our marketing efforts so that we can broaden our presence in the community. As featured on the cover, our logo was changed; we have added a tag line "guiding individual abilities," Shore will no longer be in all capital letters, and our website was re-designed by Glantz Design effective October 16, 2013. A new home for the Adult Services Program, which is located at the Lois Lloyd Center in Evanston, is being sought as we are currently on the second year of a five year lease extension from the Metropolitan Water Reclamation District of Greater Chicago. Fiscal Year 2014 will be the year for us to focus on this endeavor as we continue to search for a viable replacement to the first Shore building at 2525 Church Street. After our 2013 audit, Shore finished the year with a surplus of \$54,559 and our balance sheet is strong. All of our programs are running proficiently with positive growth in some of the programs.

Our fundraising efforts were successful with the 2012 Annual Appeal setting a new record with over \$150,000 raised; the Spring Benefit in April was the second most profitable in the agency's history, and the Second Time Around Thrift and Gift Shop, under the management of Meridith Murray, continues to thrive with nearly \$119,000 in shop sales.

Many thanks to our entire community of staff, board members, volunteers, families, and supporters for making FY '13 a successful year in serving nearly 400 children and adults with intellectual and other developmental disabilities. With your continued faith and support, I look forward to an even greater year ahead.

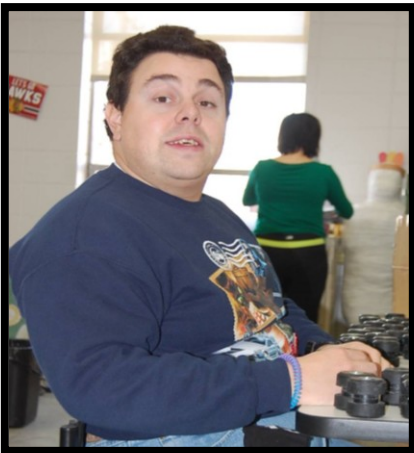

Vocational Programs

Shore Joseph Koenig, Sr. Training Center in Morton Grove is a vocational program supporting persons with intellectual and other developmental disabilities ages 16 years and older. The program seeks to enhance the individual's ability to obtain and maintain employment. Objectives include: providing employment, maintaining job performance and improving job-related skills and abilities to maximize earning potential. The Center utilizes community job sites and subcontract work from local industries to prepare individuals for employment. A Senior Services Program is also available for individuals (55 or older), who have chosen to retire. This program offers leisure-based and community activities.



- 170 individuals served during the year.
- The Sales Department had over \$153,000 in contract work from businesses in the community and repeat business increased.
- 18 persons served in the Supported Employment Program and 40 individuals were provided services at outside sites by the Community Employment Department (CED). The CED added a paper recycling program as a new site for community work experience.
- Direct Care Staff, who are core to all services at Shore, received special recognition during a week long State-wide celebration as a way to express appreciation for their fine work.
- For a consecutive year, three interns from Wright College and one from the Jesuit Volunteer Corp. completed volunteer and internship hours at the center. Also, high school students, community members and corporate groups through the United Way Days of Caring Program volunteered over 3,025 hours of service.
- Building improvements included: retrofitting over 500 internal and external lights with more energy efficient products; two bathrooms remodeled; and new carpet installed, which were made possible with grants from the Cook County Community Development Block Grant Program; a water fountain was replaced; 3 bathroom mirrors installed; and WiFi was installed in workshop area from a grant from the Morton Grove Foundation.

Shore Homes

Twelve residents reside at both Buehler House/Shore Homes East in Evanston and Shore Homes West in Skokie. The group homes are 24-hour staff supported living environments, as similar as, possible to life in mainstream society. Residents are encouraged to interact with their community and to learn to become less dependent on others. All residents are engaged in daytime employment, training or senior leisure programming.



- 24 residents received services during the year.
- In January 2012, Michelle Ess, former Program Manager of Buehler House/ Shore Homes East, was promoted to the Director of Shore Homes after the program was made independent of Residential Services. Steven Black, Program Manager at Shore Joseph Koenig, Sr. Training Center, became the Program Manager at the aforementioned facility and Jack Cox was hired as a Social Work Consultant for both group homes.
- Healthy living, with an emphasis on diet and exercise, continues to be in the forefront of all the residential programs. The residents exercise by riding the stationary bike and using the treadmill. The residents at Shore Homes West grow a garden each summer and incorporate vegetables into their cooking.

Residential Services

Residential Services now comprises the Community Integrated Living Arrangements (CILAs), Supported Living Arrangements, In-Home Respite Care Home Based Program, which includes service facilitation and personal support.

Community Integrated Living Arrangements (CILAs) are homes in the community where two to seven people reside. The Jean F. Karger House and Laura House are located in Skokie and the Brown CILA is in Evanston. The program consists of an array of services designed to meet the needs of each resident on a long-term basis. Staff support is available on a 24-hour basis. Residents attend one of Shore's day programs during the week.

The Patricia Lloyd Townhomes (PLT) in Evanston and scattered-site apartments in Evanston and Skokie comprise Shore's Supported Living Arrangements (SLA) program. The PLT are a row of five two-story units, each housing two individuals that are available to adults who are able to live more independently. Eight individuals live in the homes and most are employed in the community. Residents are responsible for themselves and their homes. A House Manager resides in one unit to provide support as needed. The scattered-site apartment residents have intermittent contact and training from staff. Services are on an as-needed basis and training includes: budgeting, housekeeping, cooking, shopping, transportation, interpersonal counseling and case management.

In-Home Respite Care eases some of the stress families endure when they are the sole caregivers of a family member with a developmental disability. In-home training is provided that assists respite recipients with communication, self-care and social skills while enabling the primary caregiver to leave the home. Objectives are developed with the input from the individual, family members and staff, which are part of an individualized program plan. A family is usually assigned one respite worker to assure continuity. Hours for respite can range from a few hours every week, to weekends or additional hours as needed.

Service Facilitation is provided for those individuals who are enrolled in the Illinois Home Base Support Services Program. The program is designed to help individuals with developmental disabilities maintain community placement within their family home. Shore's Service Facilitator provides case management and support for the individuals and their families including: identifying and assisting linkage to identified service needs for the person served.



- **32 individuals received services from the SLA and CILA Programs.**
- **Promotions included: Kirsten Luna to Director of Residential Services and Donna English to the CILA Program Manager.**
- **Furniture, a commercial washer and dryer were purchased for the CILAs, and new windows and doors were installed at Laura House through a Village of Skokie Community Development Block Grant.**
- **10 individuals received Respite Services and a grant from the Colonel Stanley R. McNeil Foundation afforded families an increase in allotted service hours.**
- **19 individuals received Home Based Service, Service Facilitation and/or personal support.**
- **A grant from the USG Foundation has given SLA residents a chance to attend free fitness classes or exercise at the Levy Senior Center, and The Elizabeth Morse Charitable Trust gave the SLA a grant for program support.**

Adult Services

The Adult Services Program, which offers developmental training for individuals 18 years and older, is located at the Lois Lloyd Center in Evanston. Participants may have multiple disabilities, including: severe/profound to moderate developmental disabilities and other physical and medical challenges. This educational program offers a curriculum in the areas of language and communication, adaptive daily living skills and prevocational skills.



- 83 individuals received services.
- Over 325 community integration activities occurred to the following places: various museums, malls, parks, restaurants, concerts, stores and other places of interest. Staff has directed more activities including: cooking, Bingo, art, literature hour, music, a play called “Apple Dumpling” and the 5th Annual Fashion Show called “Pajama Jam” with items donated from the Second Time Around Thrift & Gift Shop.
- Free monthly dental screenings continued throughout the year by the Illinois Masonic School of Dentistry.
- North Shore United Way awarded the Adult Services Program a grant to promote healthy living through the increase of fruit and vegetable consumption and physical activity. The persons served exercise regularly, which has led to 28 individuals decreasing their Body Mass Index (BMI) with a total of 332 pounds lost.
- Received 100% compliance on the Department of Human Services unscheduled annual survey.
- Dawn Beasley returned as the Developmental Activities Trainer after the position was reinstated.

Early Intervention

Early Intervention (EI) serves infants to three-year-olds who are experiencing developmental delays. Shore provides individual and group (occupational, physical, speech, and developmental) therapies and other services in a variety of locations such as our EI Center in Skokie, the child’s home, or other day care centers. The primary focus of the program is on what is best for the child and their family. Research has demonstrated that working on prevention activities with children at a very young age is much more cost effective than remedial programs at a later age.



- 40 children received services during the year.
- A playgroup continues to integrate occupational and developmental therapy along with a Polish language translator. The group was started at the request of a Child & Family Connections Service Coordinator after seeing an increase in Polish families who could benefit from this service. Fourteen children participated.
- The EI program collaborates with Wilber Wright Junior College’s Occupational Therapy Assistant Program for an eight week period for students to observe the therapists and help with general office activities.
- A grant was received from the Special Kids Foundation for an additional Occupational Therapist and the Chicago White Sox Charities donated a grant for program support.
- National Lekotek, which is an agency that works with young children with developmental delays and collaborates with Shore’s EI Program, and continues to share space at the EI Center.

Agency Re-Sale Shop

The Second Time Around Thrift & Gift Shop, located at 4123 Oakton Street in Skokie, is a re-sale shop that sells donated gently used clothing, home décor, kitchen items and more. The shop had another record year with nearly \$119,000 in sales and over \$70,000 benefiting the agency. Meridith Murray, former board president, was hired as the part-time Charity Re-sale Shop Manager at the start of the fiscal year. She must be acknowledged for the sales increase, superb volunteer recruitment/training and for continuing to make improvements at the shop i.e. a new point of sale system was implemented and the shop now accepts credit card payment on purchases. A luncheon was also held to recognize the volunteers for all their time and efforts contributed to the shop.

Over 35 volunteers operate the shop Tuesday-Saturday during the year and the Monday crew re-stocks with items that have been donated. Therefore, please keep the donations coming as they are always needed. Special thanks to Sedgebrook Retirement Community, the Winnetka Congregational Church's Woman's Society Benevolence Committee, Northbrook United Methodist Church, Modern Age Representatives, Inc., Turn the Tables, and Caroline Gau from Coldwell Banker in Northbrook for donating items to the shop. 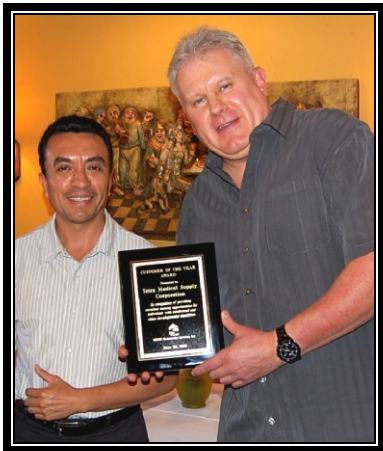
